AMCA Strategy is Advancing Nicely

In May, we reported on AMCA's new strategy, which is focused on three top activities:

- 1. Influencing regulations around the world and helping members cope
- 2. Expanding our service to members in Asia and Europe
- 3. Continuing improvements in the Certified Ratings Program

Your association is making great progress on their strategic journey crafted to continuously add value to AMCA members.



Asia AMCA Shanghai Meeting

The Asia AMCA team hosted a great event with 104 members and system $\,$

designers in attendance. This is up from 96 last year. They also convened their first official Asia AMCA board meeting and participated in the AMCA International board meeting. Your board also toured a member company's manufacturing facility, Suzhou Dingyu Energy-Efficient Equipment, who makes large fiberglass fans.

The board reviewed Asia AMCA's financial performance as compared to the pro-forma used to justify the joint venture. That pro-forma represented the projected annualized average for the first two years. Actual performance, annualized after the first 6 months, is just shy of the projected 2-year average by 5.8%, which is very good. Asia AMCA is doing quite well.

New Participation Incentives

The board agreed to provide incentives (rewards) for meeting participation—\$25 for a telephonic meeting, \$75 for an in-person meeting, and double these amounts for the committee chair. Credits can be used to offset annual meeting expense starting with the 2013 meeting. The board also approved \$1,000 dues credit to all companies that report to the statistics program for 12 consecutive months, starting July 1, 2012.

As an inducement to attract new members, the board also agreed to waive first year assessments for new members. This recognizes that new members enjoy added value after their product lines are certified and promoted in the marketplace, which takes about a year.

European AMCA

The board approved the European AMCA bylaws. Our formal incorporation as a European Association is in process, waiting for documents to be translated into French. We expect to have this completed before our annual meeting. Mark Stevens has met with a committee of European members who drafted European AMCA's EU-327 Verification program, which is also expected to go out for a member vote before the annual meeting.





DOE Task Force Progress

Two task force groups, Product and Systems, met for the first time on July 31 at AMCA headquarters. Both have developed mission statements and have begun their journey that is expected to average two meetings per month.

The Product group is focused on generating statistics so we can project the energy used and the fan's average efficiency at the actual design point. This data will be based on member orders received in 2011 for the major fan categories. This will allow the task team to determine where the greatest opportunities lie and to quantify the projected savings from different regulatory limits.

The Systems team is working to document an objective comparison of savings potential by category, including fan, motor, and drive design; selection point; duct leakage; system effects; and air-system design. This team will then consider actions outside the DOE regulations, which will have the greatest impact on energy savings.

Statistics Program

We researched 78 American companies in our industry who are not AMCA members. Senior staff used this research to assign an estimate of sales by broad product category to each company, the total of which was \$409 million. This breaks down as follows:

Centrifugal Fans \$125 million
Axial & Prop Fans \$190 million
Powered Roof Vents \$27 million
Louvers & Dampers \$67 million

Reported markets from member companies total about \$1 billion. Next, staff is soliciting information from AMCA members who do not report. This effort will be done in October. By year end, we will have what we need to begin reporting expanded market estimates, in addition to the market data we provide today. Expanded market estimates will compensate for companies that never report, and for those who fail to report consistently. This, plus the \$1,000 incentive for full reporting, should take our statistics program to a higher level.

AMCA Call for Engineering Papers

The next AMCA International Engineering Conference is scheduled to be held June 3-4, 2013. This conference will be held in San Antonio, TX, in conjunction with the ASME Turbo Expo 2013.

AMCA International Engineers and other experts in the industry are invited to submit a paper for presentation at the 2013 AMCA International Engineering Conference. A paper should be designed for a presentation length of approximately 50 minutes. Please submit an abstract consisting of one page, maximum, for review by the AMCA Engineering Standards Committee. Although any technical topic in the industry will be acceptable, particular attention will be afforded papers describing efforts to assist in improving the environment we live in. Papers describing real world problems and solutions have always been favorites in the past. Each presentation may be supported by visual aids; support may be included with the abstract if desired.

The deadline for submitting an abstract is October 1, 2012. Final papers and presentation material will be due March 1, 2013.



New Incentive program

Your AMCA board approved a new committee meeting participation program. Revised AMCA Publications

AMCA International Publication 511-10 (Rev. 8/12), Certified Ratings Program- Product Rating Manual for Air Control Devices
This revision includes new rating sections for duct access doors and transverse duct connectors as well as corrections to leakage ratings as determined by the Publication 511 Technical Committee.

AMCA International Publication 211-05 (Rev. 6/12), Certified Ratings Program - Product Rating Manual for Fan Air Performance This revision includes language for making adjustments to fan performance when determining check test failures.

AMCA Member Survey – Drawing Winners
